Ethics and Publication Malpractice Statement

Rights and responsibilities of authors

Originality of the article. Quotation of sources. Liability in case of plagiarism. By submitting an article to the journal Scripta Manent for publication, the author guarantees that the manuscript contains his/her own original work and that it was not previously published. The authors also guarantee that non-manuscript passages have been properly attributed, by appropriate bibliographic references and by using quotation marks. The entire responsibility lies with the author/authors of the article in case of non-compliance with the copyright/plagiarism legislation, the editorial board of the journal Scripta Manent being unable to assume any responsibility for the authors' non-compliance with the regulations included in the copyright/plagiarism legislation and for plagiarism. In case of discovery of non-compliance with copyright/plagiarism legislation, the manuscript will be rejected and the published article will be withdrawn from the journal. The editorial board of the journal Scripta Manent does not assume responsibility for the views expressed by the authors in the published articles.

Compliance with the requirements for writing the manuscript. The manuscript sent to the Editorial Board must comply with the drafting requirements set out in the Editorial Regulations of the journal Scripta Manent.

Non-acceptance of redundant publication. The journal Scripta Manent does not accept to publish, in the same language, works that have already been presented in part or in full in a published article or that are described in another article sent or accepted by other written or electronic publications. If a redundant publication is discovered, the manuscript will be rejected and the published article will be withdrawn from the journal.

Authorizations for reproduction and copyright. It is the responsibility of the authors to obtain the authorizations of reproduction and copyright regarding the inclusion as such or adaptation in the article of images/works of art or documents/texts for which they do not have

copyright. The copyright holder will have to be expressly informed that the images/artwork or

documents/texts will be posted online and can be accessed free of charge as part of the article.

Giving the names of those who have contributed to this article. The names of the

authors must be written in order of their contribution to the article. All authors must take

responsibility for their contributions. Only people who make a substantial contribution to the

article should be listed as authors. Those whose contributions are indirect or marginal may be

mentioned in a separate section in a section of "thanks" at the end of the respective issue of

Scripta Manent.

Protection of copyright in articles published in the journal Scripta Manent. The

authors of the manuscript agree that if the manuscript is accepted for publication in the journal

Scripta Manent, the copyright will be protected in accordance with the legal provisions. This

means that all the content of the Scripta Manent online magazine on the

http://www.grefieri.ro:808 website is available free of charge without charging any fees to the

user or his institution.

Sending the manuscripts by e-mail only. Manuscripts intended for publication shall be

sent by the authors only electronically to the following e-mail address: revistasng@grefieri.ro.

How to take responsibility. By submitting the manuscripts for publication in the journal

Scripta Manent, the authors assume the responsibility that the document belongs to them, that

the sources have been correctly quoted and that they have not reproduced materials from

unauthorized sources.

Discovery of significant errors or inaccuracies in published articles. If an author

discovers a significant error or inaccuracy in an article of his that has been published in **Scripta**

Manent, he is obliged to immediately notify the editors and cooperate with them to correct the

article or retract it, as appropriate.

Rights and responsibilities of scientific reviewers

Evaluation system. The manuscripts received for publication in the journal Scripta

Manent are subject to peer review evaluation, respecting the international standards of scientific

journals. Any article submitted for publication will be evaluated by scientific reviewers with a

recognized national and international reputation in the field of legal sciences. Authors will be

informed about the recommendations and comments of reviewers in order to improve the quality

of the article. Upon the proposal of the reviewers, the publication of the article may be refused.

out their activity based on their work duties. The chief editor will send the manuscript for

evaluation to at least 2 reviewers with scientific competence in the field under research. Within

three weeks of receipt of the manuscript in an editable format, scientific reviewers are required to

verify the document and make any comments they deem necessary. Subsequently, both the

manuscript in its original form and the modified version with the comments made by the

reviewers are sent to the author in order to adapt the original version, in accordance with the

observations resulting from the examination of the document.

Confidentiality of information and ideas obtained during the evaluation. Inside

information or ideas obtained through the evaluation process must remain confidential and not be

used to obtain personal advantages. Any manuscript received for consideration must be treated as

a confidential document.

Objectivity of assessment. When conducting the evaluation, reviewers are asked to do

so as objectively as possible, refraining from engaging in personal criticism of the author/authors.

Reviewers must express their views clearly, explaining and motivating the recommendations

made.

The content of the assessment. Reviewers must submit to the chief editor any major

similarities between the manuscript under review and other published articles or papers of which

they are aware, as well as any issues that would relate to the ethical acceptability of the research

described in the manuscript. In carrying out the evaluation, scientific reviewers will also take into

account the provisions contained in COPE Ethical Guidelines for Peer Reviewers publicat de

Committee on Publication Ethics (COPE). Following the evaluation, scientific reviewers may

recommend: publication of the article, publication of the article only if the observations made in

the evaluation form are observed, non-publication of the article.

Rights and responsibilities of publishers

Final decision of publication. The chief editor has the ultimate responsibility to decide

whether or not a manuscript will be published, taking into account the assessments made by

scientific reviewers, compliance with the provisions of this statement of ethics and malpractice

and copyright protection legislation. The chief editor may consult with the other members of the

Editorial Board, as well as scientific reviewers in making publication decisions.

around the world. Scripta Manent recognizes that worldwide, regulations on the ethics of

scientific research may differ from country to country. Accordingly, the editors may request

clarification in this regard from the author(s) of the manuscript and send information letters to the

institutions responsible for the ethics of scientific research in the author's country of origin and/or

to international organizations active in the field.
