The **National School of Clerks (NSC)**, in partnership with the **National Institute of Magistracy (NIM)** and other national training institutions responsible for the training of judges and court clerks in five EU Member States – Bulgaria, Italy, Poland, Portugal, and Spain – announces the launch of a **selection procedure** for participation in the **fifth transnational training cycle** of the **CiviLink Project** – including *three video tutorials, a preliminary webinar and a transnational seminar* on cross-border judicial cooperation in civil matters and e-CODEX. The project is co-funded by the European Union under the name “*CiviLink: Connecting Borders through e-CODEX Judicial Training*” (Grant Agreement 101189956).

### PERIOD AND VENUE

The **webinar** will take place in **April 2026 (exact date will be confirmed)** and the **seminar** will be held on **05-06 May 2026** in Lisbon, Portugal. Prior to the webinar, participants will be required to follow **three short tutorials**, in order to be adequately prepared for practical discussions and exercises.

### TARGET GROUP:

This fifth transnational training cycle will bring together 30 participants from Bulgaria, Italy, Poland, Portugal, Romania, and Spain – 22 judges and 8 court staff. For this cycle, **5 places are allocated to Romanian court clerks**. The National School of Clerks will also create a reserve list in case of an increase in available spots, participant withdrawals, or the inability of initially selected candidates to attend.

### WORKING LANGUAGE

The video tutorials, webinar, and seminar will be conducted in English. Participants must have a good command of English (minimum level B2).

### DESCRIPTION

*CiviLink: Connecting Borders through e-CODEX Judicial Training* is a European project coordinated by the National Institute of Magistracy (NIM - Romania), in collaboration with the Centre for Judicial Studies (CEJ – Portugal), the Judicial School of the General Council for the Judiciary (CGPJ – Spain), the National Institute of Justice (NIJ – Bulgaria), the National School of Judiciary and Public Prosecution (KSSiP – Poland), the School of the Judiciary (SSM – Italy), and the European Judicial Training Network (EJTN).

The project aims to strengthen cross-border judicial cooperation in civil matters by equipping judges and court staff with practical skills for using the e-CODEX system in the application of Recast Regulations (EU) 2020/1783 and 2020/1784 on the service of documents and the taking of evidence.

Through a comprehensive blended learning cycle, the project combines six transnational seminars - each preceded by an introductory webinar - and supported by e-learning tools including tutorials and reflective podcasts, all conducted in English. This structured approach not only enhances practical skills but also fosters cross-border dialogue among justice professionals, facilitating a harmonized application of EU law in civil cases across six Member States.



## CiviLink Training Cycle Description

The CiviLink project offers a structured, blended learning path for European judges and court staff, combining digital and in-person training to enhance cross-border cooperation in civil matters using e-CODEX and the Recast Regulations (EU) 2020/1783 and 2020/1784.

The training cycle includes:

- Short video tutorials for introductory familiarisation with the e-CODEX system
- Interactive webinars for conceptual grounding and practical understanding
- In-person transnational seminars for practical, case-based exercises and simulations
- Reflective podcasts for post-training consolidation of key concepts
- A final conference to share experiences and project results at the European level

### ***Pre-training Webinar (half-day online - April 2026 - exact date will be confirmed) will:***

- Introduce the Recast Regulations and their practical relevance
- Present the structure, legal value, and Reference Implementation of the e-CODEX system
- Demonstrate workflows for the Service of Documents (SoD) and the Taking of Evidence (ToE)
- Cover data protection and cybersecurity requirements in digital judicial cooperation
- Provide a preview of the practical seminar and address participant questions.

### ***The 1.5-day seminar (05-06 May 2026, Lisbon, Portugal) will:***

- Apply the Recast Regulations in simulated cross-border civil cases
- Provide hands-on training on using e-CODEX for SoD and ToE procedures
- Discuss practical challenges and troubleshooting in digital cooperation
- Cover GDPR compliance and data protection responsibilities
- Facilitate cross-border peer learning and professional networking among EU judges and court staff.

### **FUNDING**

According to the rules established by the Grant Agreement concluded with the European Commission and in accordance with the provisions of the Consortium Agreement between NIM and NSC:

- Accommodation expenses (including reservation) shall initially be covered by the participants and will be reimbursed after attending the seminar, upon submission of the relevant supporting documents, up to a limit of 170 EUR per night for a maximum of 2 nights.
- Transportation costs, within a limit of 450 EUR/roundtrip, shall also be initially covered by the participants and reimbursed under the same conditions as above.

- Participants will be reimbursed for daily subsistence costs up to 83 EUR per day, for a maximum of 2 days. The reimbursable amount may be adjusted to reflect any catering / social dinner costs / other costs, should the organizers choose to arrange such services.
- NSC / NIM does not provide or reimburse travel medical insurance. Participants may choose to obtain such insurance at their own expense or to use the European Health Insurance card or an equivalent supporting document, which grants access to emergency medical services free of charge within the EU.

**Important notice:** before making any arrangements, participants must wait for confirmation from the National Institute of Magistracy (NIM) coordinator. NIM will notify all applicants whether their participation has been confirmed.

Court clerks on the reserve list may be invited in the event of an increase in available spots, participant withdrawals, or if initially selected candidates are unable to attend. If, after the selection process, a selected participant is unable to attend the fifth cycle of training, they are kindly requested to inform both the National School of Clerks (NSC) and the National Institute of Magistracy (NIM) immediately.

By submitting the application documents, candidates agree that, if selected, their participation will take place exclusively under the financial conditions specified by the National Institute of Magistracy (NIM) coordinator.

### WHO CAN APPLY?

- Court staff with experience in cross-border civil (family law included) or commercial proceedings
- English language proficiency is required (the training will be conducted in English)
- Participants committed to attend both the webinar and seminar in full and to follow the tutorials
- Participants willing to contribute to the project's reflective learning podcasts by sharing their experience and feedback after the seminar
- Participants motivated to apply the acquired knowledge and disseminate it within the judiciary

*Gender and age balance, jurisdictional diversity, and geographical diversity will be pursued during selection.*

### EXPECTED OUTCOMES

Through this cycle, participants will:

- Strengthen their practical skills for implementing EU cross-border judicial procedures digitally
- Gain confidence in using e-CODEX in light of its mandatory implementation
- Enhance their understanding of the Recast Regulations' impact on civil judicial cooperation
- Develop networks with EU colleagues to support the uniform application of EU law
- Receive a certificate of participation upon successful completing the full cycle (the short video tutorials, one webinar, one seminar)
